


Responsible for on-site care and off-site specialty care that is directly rendered to the incarcerated individual.

Does your business meet the requirements to become Small Business (SB) or Disabled Veteran Business Enterprise (DVBE) certified? If so, visit https://www.dgs.ca.gov/PD/Services/Page-Content/Procurement-Division-Services-List-Folder/Certify-or-Re-apply-as-Small-Business-Disabled-Veteran-Business-Enterprise for tools and resources on the certification process.

Note: Awarding departments may apply a SB/ DVBE incentive up to five percent in competitive solicitations. The incentive provides an advantage to bidders who utilize SB/DVBEs to fulfill the required three percent contract participation.
