CLASSIFICATION DETAILS

Nurse Practitioner, Correctional Facility (9278) –

\$11,368 - \$12,851 per month - This range shall apply to positions at the Department of Corrections and Rehabilitation within Correctional Health Care Services Division and Adult Institutions (except for positions at the following locations: San Quentin State Prison, Correctional Training Facility, and Salinas Valley State Prison).

\$11,368 - \$13,344 per month - This range shall apply to positions at the Department of Corrections and Rehabilitation within Correctional Health Care Services Division and Adult Institutions at the following (Bay Area only) locations: San Quentin State Prison, Correctional Training Facility, and Salinas Valley State Prison.

Who Should Apply:

Applicants who meet the minimum qualifications as stated on this bulletin may apply for and take this examination.

Once you have taken this examination, you may not retake it for six (6) months.

MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Nurse Practitioner, Correctional Facility

Possession of a current license as a Registered Nurse in California. (Applicants who do not meet this requirement will be admitted to the examination, but they must secure the required license before they will be considered eligible for appointment.)

And

Possession of a current certification as a Nurse Practitioner by the Board of Registered Nurses. (Applicants who do not meet this requirement will be admitted to the examination, but they must secure the required certificate before they will be considered eligible for appointment.)

Special Personal Characteristics: Empathetic understanding of patients of a State correctional facility; willingness to work in a State correctional facility; emotional stability; patience; tact; alertness; and keenness of observation.

Special Physical Characteristics: Persons appointed to this position must be reasonably expected to have and maintain sufficient strength, agility, and endurance to perform during stressful (physical, mental, and emotional) situations encountered on the job without compromising their health and well-being or that of their fellow employees or that of inmates.

Assignments may include sole responsibility for the supervision of inmates and/or the protection of personal and real property.

Applicants possessing the required license/certificate at the time of application must show the number, title, and expiration date on their Examination Application (Std. Form 678).

POSITION DESCRIPTION

Nurse Practitioner, Correctional Facility

A Nurse Practitioner, Correctional Facility, under the supervision of a physician, in a State correctional facility in the California Department of Corrections and Rehabilitation, provides direct and indirect patient care services under written and approved standardized procedures; maintains order and supervises the conduct of inmates; protects and maintains the safety of persons and property; and does other related work.

Positions exist statewide.

EXAMINATION SCOPE

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consist solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each examination component will be measuring competitively, relative to job demands, each applicant's:

Knowledge of:

1. Current trends and concepts of professional nursing practices;
2. Laws and regulations relating to the nurse practitioner scope of practice;
3. Principles and practices of clinical assessment of common health problems;
4. Principles of mental health;
5. Causes, treatment, and prevention of communicable diseases, chronic diseases, mental illness, and other disabling conditions;
6. Continuity of patient care and the community health care resources.

Ability to:

1. Work effectively with individuals to assist them in solving physical, mental, and social health problems;
2. Communicate effectively;
3. Prepare clear and concise reports;
4. Recognize social problems which affect health;
5. Instruct in the prevention of disease, good health practices, and the health care of an ill or injured person;
6. Participate in the development of standardized procedures;
7. Construct and interpret a medical history, perform a physical assessment, evaluate patient behavior, perform and interpret laboratory tests, and identify problems and develop and implement treatment plans for patients;
8. Maintain effective working relationships with health care professionals and others.

ELIGIBLE LIST INFORMATION

A departmental, open eligible list for the Nurse Practitioner, Correctional Facility classification will be established for:

California Correctional Health Care Services

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of examination date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

GENERAL INFORMATION

Examination and/or Employment Application (Std. Form 678) forms are available at CalHR, local offices of the Employment Development Department, and through your [CalCareer Account](#).

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

CCHCS reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification from the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
